President's Report-Sally O'Meara

President's report was tabled- noting the amazing work Lucie has done in achieving grants. WHN would not be where it is without the grants to help support the community. Disappointment with the failure of the Voice To Parliament which was closely aligned with the values of WNH- had a strong support in Watsonia.

Manager's Report – Lucie Holden.

The Manager gave a powerpoint presentation on her work that was completed throughout the year. Including helping those in vulnerable circumstances through advocation and building connections. WNH turns \$1.00 received through State Govt, Banyule CC, grants and self generated monies into \$3.28 value provided income. 10 funding applications generated \$47 116.00. Hours worked comes from 3 part time employees 63 hours, 36 volunteers 70 hours.

Treasurer's Report- Bob Regan

The House has been profitable for 6 out of the last 9 years with this year having a deficit of \$4 300.00 far lower than had been estimated. Money has been spent wisely with more staff and programs and has a good sound base for overspending to keep programs running.
